Without income records, we will be unable to process your request. Alternately, you may send us an award letter from a service such as Free & Reduced Lunch program, Food Stamps, or certain other social services. We will contact you once your application has been processed to let you know if we are able to provide a discount and if there is still room in the desired session.*

Income-Based Discount Eligibility Guidelines

The following chart details eligibility for families applying for these discounts. These figures mirror income guidelines set up by the Colorado Department of Education Free/Reduced Lunch program. To determine eligibility status you will compare your gross annual income from your most recent IRS Form 1040 along with the number of members in your household to the information in the following chart.

Household Size	Annual Income Up to 50% discount towards one week of camp per child
2	\$32,227
3	\$40,626
4	\$49,025
5	\$57,424
6	\$65,823
7	\$74,222
8	\$82,621
For each additional member of the household add:	\$8,399

Need assistance but don't qualify? Check out our Last Minute Program: The Last Minute Program is designed for families who are looking for tuition assistance who may not qualify for our income based discounts. Often, throughout the summer, we have spots that are unfilled in our camp sessions. We strive to fill those openings with campers whose families may not be able to afford our full tuition. This program gives a 40% discount off of the usual session fee and is available to all day camp programs at all locations. The Last Minute Discount can be requested for multiple weeks.
